

President's Soapbox



This quarter has been pretty busy for me. Starting off in April with a couple of trips representing the NM SAR. Starting off in San Antonio for the Texas SAR convention, or annual meeting. This was quite the contrast comparing our annual meeting to this.

Of course the TX SAR has over 50 chapters and about 2500 members, but it makes me think that even though we a small society, we can do better. All it takes is an engaged membership!

The Texas convention was a 3 day event, much like the bi-annual Leadership meetings in Louisville. It was a great event and well attended by not only TX SAR members, but others from around the country. I was very impressed with the entire event and how it was run.

One of the sessions of particular interest was a presentation on the Club Express membership program in which TX SAR has joined. Many of the features of the program were presented and although TX already has an online dues payment program in place, they are interested in making the switch to Club Express. So if it can serve a society with over 2500 members well, it should be of great benefit to us. I have enrolled NM SAR in the pilot program and was given administrator permissions, but there has not been much movement since. Hopefully I will have more to report after Congress in Lancaster in July.

Next, at the end of April, I traveled to Portales and met Compatriot Wheeler for the re-internment service for PVT Homer J. Mitchell, who was killed in action in Germany during WWII. (On this same day, 1st VP TJ Vallejos represented Gadsden at the service at Fort Bayard for PFC Richard G. Pitsor who died in captivity in the Philippines during WWII).

Immediately after this service I was off to Gainesville, TX to march with the TX SAR color guard for the Medal of Honor parade. According to their website, as of last year, since 2001 the City of Gainesville has hosted 56 of the 66 living Medal of Honor recipients. Although the parade attendance was down this year due to the threat of severe weather, but it was still an extraordinary event and well worth the effort to go.

Also at our April meeting, we brought in our "Patriot Chest" with all the items that have been purchased to date with the grant funds from Americana Corner. Most of these items were not available for our first 2 presentations and we are looking forward to showing these to the students when our presentations resume in the fall semester.



Our May meeting was filled with Award and Medal presentations. Several members and supporters were presented the Bronze Henry Knox medals for their service to the chapter, and we also presented a Life Saving medal to a member of Dona Ana Fire for his actions, while off-duty, in saving the life of a traffic accident victim. Our June meeting was our annual combined SAR/DAR meeting with the Dona Ana DAR hosting. The meeting room was packed and our color guard posted the colors to start the meeting off. (Of note, I was finally able to obtain some of the Spanish Presidio soldier uniforms and one of our CG members has chosen to wear one of these). Regent Bissell was gracious enough to allow me to present some of the Henry Knox medals to those who could not attend our May meeting. We also were fortunate to be able to honor an individual with a Heroism medal for his actions in stopping a vehicle driving on highway 70, whose driver was slumped over the steering wheel, unconscious. Prior to this meeting, myself, Dave Curtis and Don Williams attended the Las Cruces PD's annual awards ceremony and presented 2 Law Enforcement medals to a detective and a school resource officer and our Gadsden Medal to Police Chief Jeremy Story. GAASAEN GAZEJJE

Lastly, as of July 1st, nominations are open for NM SAR officer positions for the 2025 officer elections at our annual state meeting, tentatively scheduled for Saturday February 1, 2025.

With that said, I have enjoyed serving you and representing NM at all the various events I have attended since my election, including the Council of State Presidents at the Spring Leadership meeting in Louisville and the Texas SAR state convention in San Antonio in April. I will be attending the 134th Annual Congress in Lancaster, PA and back to Louisville in October and plan on attending the Council of State Presidents meetings at those events. I have been looking into ways that we can build up our camaraderie, such as the upcoming NM SAR member/family picnic in August and to recognize members for their dedication and efforts to serve our Society. I have also been working with Lee Popham to enroll NM in Club Express for a new membership database program.

Therefore, I intend to forward my name to the nominating committee and ask for your support to serve you for another year as your NM SAR president, if you will have me.

With your help, I believe we can continue to do great things for our Society.

NM SAR NEWS

There hasn't been a lot happening to report on regarding our state. A couple of things that I might note though include something from the "Brand and Engagement Guide" published by National June 15, 2023. As you may have noticed, I have begun referring to our state as NM SAR or New Mexico SAR, not NMSSAR. The brand and engagement guide is "designed to provide the guidelines for consistently representing and promoting the SAR to the public, to our members, and to our communities."

In the guide, under "SAR Organization Designation Protocols", The word Society is eliminated for District, State and Chapter designations. Hence, we should no longer go by New Mexico *Society* SAR (NMSSAR). It should be New Mexico SAR (NM SAR). Society remains in use for National.

On May 24th, we held a BOM meeting to address 2 items that needed BOM approval. First, we modified our "Dues and Fees Schedule" and eliminated the \$10 fee for reinstatement. We also authorized the treasurer to move our state checking account into an interest bearing account. As noted in the President's Soapbox, а member/family picnic is scheduled to be held in Ruidoso on Saturday, August 17th. The location has changed due to the recent wildfire in the area and another reminder will go out as we get closer to the event. So far, 21 members and guests have indicated their intent to attend, only 2 of those are not from Gadsden. Hopefully we can gin up more interest from around the state.

NSSAR NEWS

There have been some significant changes made in the Genealogy Committee Policies regarding the handling of applications, most notably, you can only replace the patriot on any application 1 time instead of 3. Also the time pended applications are held before being withdrawn has been reduced from 3 years to 2.

There has been discussion about raising the NSSAR application fees \$50, from \$100 to \$150, although there has been some pushback about that amount. It has not been adopted and will probably be discussed at Congress. Whatever the eventual outcome is, you will be notified.

There has not been any movement in the last few weeks with getting the Club Express membership database program up and running for NM.

Revolutionary War History

On June 13, 1777, a 19-year-old French aristocrat, Marie-Joseph Paul Roch Yves Gilbert du Motier, <u>Marquis de Lafayette, arrives</u> in South Carolina with the intent to serve as General<u>George</u> <u>Washington</u>'s second-in-command.

Silas Deane, during his service as the Continental Congress envoy to France, had, on December 7, 1776, struck an agreement with Johann de Kalb and Lafayette to offer their military expertise to the American cause. However, Deane was replaced with <u>Benjamin Franklin</u> and Arthur Lee, who were unenthused by the proposal. Meanwhile, King Louis XVI feared angering Britain and prohibited Lafayette's departure. The British ambassador to the French court at Versailles demanded the seizure of Lafayette's ship, which resulted in Lafayette's arrest. He managed to escape, set sail and eluded two British ships dispatched to recapture him.

Following his safe arrival in South Carolina, Lafayette traveled to Philadelphia. Although Lafayette's youth made Congress reluctant to promote him over more experienced colonial officers, the young Frenchman's willingness to volunteer his services without pay won their respect and Lafayette a commission as major-general on July 31, 1777.

Lafayette served at Brandywine in 1777, as well as Barren Hill, Monmouth and <u>Rhode Island</u> in 1778. Following the formal treaty of alliance with Lafayette's native France in February 1778 and Britain's subsequent declaration of war, Lafayette asked to return to Paris and consult the king as to his future service. Washington was willing to spare Lafayette, who departed in January 1779. By March, Franklin reported from Paris that Lafayette had become an excellent advocate for the American cause at the French court.

Following his six-month respite in France, Lafayette returned to aid the American war effort in <u>Virginia</u>, where he participated in the successful siege of Yorktown in 1781, before returning to France and the further service of his own country.

FLAG DAY

June 14, 1777: During the American Revolution, the Continental Congress adopts a resolution stating that "the flag of the United States be thirteen alternate stripes red and white" and that "the Union be thirteen stars, white in a blue field, representing a new Constellation." The national flag, which became known as the "Stars and Stripes," was based on the "Grand Union" flag, a banner carried by the Continental Army in 1776 that also consisted of 13 red and white stripes. According to legend, Philadelphia seamstress Betsy Ross designed the new canton for the Stars and Stripes, which consisted of a circle of 13 stars and a blue background, at the request of General George Washington. Historians have been unable to conclusively prove or disprove this legend.



5 Facts For Flag Day - June 14th

#1 - The US' 50-star flag was designed by 17 yearold Bob Heft for history class in 1958. His gradewas a B-.

#2 - There's an official "Flag Code" for displaying and handling the American flag. It's technically federal law!

#3 - The proper way to dispose of an American flag? Burn it.

#4 - Always raise your flag briskly, but lower it slowly. And never let it touch the ground.

Archaeology of the American Revolution

As some of you may know, I received my Masters in Anthropology in May. The degree allows me to conduct Archaeology with a greater knowledge base than my undergraduate. I wanted to take this opportunity to share this knowledge in relation too our common interest in the American Revolution. At the most basic level, Archaeology is understanding people of the past through their material culture (aka their stuff), as opposed to Historians who understand people of the past through their written record. Our membership applications are based on the written record, but Archaeology can provide additional perspectives to those documents. Marginalized peoples, such as Women and People of Color, were less represented in the documentation of the period, but this can be mitigated by excavating their homes and studying the artifacts recovered to give light to domestic and religious practices, health. diet. trade networks. illicit activities, etc. While a range of scientific analyses can determine such things, the context in which the artifacts are found is key. If a button associated with Patriots is found on a battlefield, it may contribute to the knowledge of maneuvers taken during the battle, but if such a button is instead found in the house of a publicly Loyalist person, interesting possibilities begin to form to explain such an unexpected find.

Sadly, these important contexts are often lost by the looting of archaeological sites by souvenir hunters, metal detectorists, collectors, etc. While there are laws to protect such places on public lands, private property is not protected and is thus subject to contextual loss. There is a understanding greater among the Archaeological community that such losses are unpreventable and there are moves to collaborate with such collectors on an equal footing since both groups are interested in the past and wish to preserve it for future generations. Thank you to President Vance for providing me with this opportunity to ramble on my profession. Chaplain's Corner

Fearless in Fulfillment of His Duty

One chaplain, Baptist minister David Jones, also served as a missionary to the Indians of the Ohio Valley for two years. He was so outspoken about his views on the Revolutionary War that "he became obnoxious to his Tory neighbors" and was compelled to leave the Freehold Baptist Church where he served as pastor. After this episode, David Jones moved to Chester County, Pennsylvania, to become the pastor of the Great Valley Baptist Church. He soon realized, however, that he needed to help the colonial struggle for freedom. He entered the army as a chaplain and served in this position until the

end of the war. It was Chaplain Jones' custom to preach as often as possible before entering battle, and he preached to the troops at Valley Forge, following the arrival of the news that France had recognized American independence. Jones served under the command of General "Mad Anthony" Wayne, a Chester County native. General Wayne earned his nickname for the bravery and fearlessness he displayed on the battlefield. David Jones was a good fit with his commanding officer in this regard. He was so heroic on the battlefield that British General Howe offered a reward for his capture, and many plots were laid to capture him. In addition to his military and chaplain's duties, Jones also served as courier for General Wayne from time to time. In a letter to Benjamin Franklin, written from Ticonderoga on July 29, 1776, Wayne writes: We are so far removed from the seat of Government of the free and independent states of America, and such an Insurmountable Barrier, Albany, between us that not one letter, or the least intelligence of anything that's doing with you can reach us. Through the medium of my Chaplain (David Jones) I hope this will reach you as he has promised to blow out any man's brains who will attempt to take it from him.




